## A. FAR CLAUSES INCORPORATED BY REFERENCE

This Order incorporates one or more clauses by reference, with the same force and effect as if they were given in full text. Upon request Two Six Technologies will make their full text available. When the materials or services furnished are for use in connection with a U.S. Government prime contract in addition to the Two Six Technologies Subcontracts Terms and Conditions, the following provisions shall apply. The effective version of each Federal Acquisition Regulation (hereinafter "FAR") provision shall be the same version as that which appears in Buyer's prime contract or higher tier subcontract under which this Subcontract is a subcontract. In the event of a conflict between these FAR provisions and the Subcontract Terms and Conditions of Purchase, the FAR provisions shall control.

The following clauses set forth in the FAR in effect as the date of Two Six Technologies prime contract or higher tier subcontract are incorporated herein by reference. In all clauses listed herein, the terms "Government". "Contracting Officer" and "Contractor" shall be deemed revised to suitably identify the contracting parties herein and effect the proper intent of the provision except where further clarified or modified below. "Subcontractor", however, shall mean "Seller's Subcontractor" under this Order.
